What is this product?

Type

The product is a share class of O3 Asset Value SICAV, an open-ended investment company with variable capital (société d'investissement à capital variable - SICAV) governed by Part I of the Luxembourg Law of 17 December 2010, as amended (Law of 2010), and thus qualifies as a UCITS.

Term

The fund has no maturity date. Notwithstanding this provision, the fund, in keeping with the articles of association, may be dissolved at any time by resolution of the general meeting.

Objectives

Investment objective

The objective of the O3 Asset Value SICAV investment policy is to achieve appropriate capital growth in the fund currency. The fund is actively managed. The composition of the portfolio is established, regularly reviewed and adjusted where appropriate by the fund manager exclusively in accordance with the criteria that are defined in the investment objectives / investment policy. The fund is not managed using an index as a benchmark.

Investment policy

In principle, the fund may, according to the market position and the judgement of the management company or the fund's management, invest in shares, bonds, money market instruments, certificates, other structured products (e.g. reverse convertible bonds, warrant-linked bonds, convertible bonds), target funds and fixed-term deposits. Shares in UCITS or other UCIs ("target funds") may be acquired in excess of 10% of the fund's assets, and the fund is therefore not eligible as a target fund. The fund does not promote

sustainable features or have the objective of sustainable investment within the meaning of Article 8 or Article 9 of Regulation (EU) 2019/2088. In accordance with the provisions of Article 7 of Regulation (EU) 2020/852 (EU Taxonomy), attention is drawn to the following in this context: the investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities. Dividend policy

The income remains in the fund.

Subscription and redemption

Shareholders redeem their shares on any banking day in Luxembourg, with the exception of 24 and 31 December. For details on return options, please refer to the section "How long should I hold the investment and can I withdraw money early?".

Intended retail investor

The fund is aimed at all types of investors who pursue the goal of asset accumulation or asset optimisation and wish to invest in the long term. They should be able to bear losses up to the amount of the capital invested.

The risk indicator is based on the assumption that you will hold the product for 5 years.

What happens if ETHENEA Independent Investors S.A. is unable to pay out?

The default of ETHENEA Independent Investors S.A. has no direct impact on your payout, as the statutory regulation provides that in the event of the insolvency of ETHENEA Independent Investors S.A., the special assets do not become part of the insolvency estate, but are maintained independently.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product performs, if applicable. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Due to the risk and return profile, we recommend a holding period of at least 5 years for this product.

However, you can return the product in accordance with the return procedures specified in the Sales Prospectus. An early return can significantly affect the risk and return profile. The redemption of shares may be suspended if exceptional circumstances appear to make this necessary, taking into account the interests of the shareholders, or limited if the shareholders' redemption requests reach a predefined threshold above which said requests can no longer be executed in the interests of the shareholders as a whole. The redemption period may be extended if this is necessary in the interests of the shareholders. The Management Company may separate certain assets whose economic or legal characteristics have changed significantly or become unsafe due to exceptional circumstances from the other assets of the Fund.
